1. CALL TO ORDER

Mayor Bolivar-Getson called the Special Council meeting to order at 7:26 p.m. She advised a Public Hearing was just held with regard to the proposed adoption of the Oakland Secondary Planning Strategy and Land Use By-law which would repeal the existing 2003 documents. At the conclusion of the Public Hearing, Council agreed to hold a Special Council meeting to make their decision on this matter.

2. <u>SECOND READING – Proposed New Municipal Planning Strategy and Subdivision</u> <u>By-law</u>

Council conducted First Reading on the proposed Oakland Secondary Planning Strategy and Land Use By-law on February 12, 2019, at which time Municipal Council agreed to provide Public Notice of its Intent to:

- Conduct Second Reading of draft version 3.1 of the Oakland Secondary Planning Strategy and Land Use By-law;
- Adopt draft version 3.1 of the Oakland Secondary Planning Strategy and Land Use Bylaw dated December 12, 2018.
- Repeal the September 9, 2003 Oakland Secondary Planning Strategy and Land Use Bylaw, effective upon publication of a Public Notice

A Public Information meeting was held on March 5, 2019 and the Public Hearing just concluded. Council agreed to hold this Special Council meeting to make a decision on this matter and conduct Second Reading.

Council now has three options: it can choose to either:

- <u>approve</u> the documents;
- <u>not approve</u> the documents; or
- <u>defer</u> a decision.

Moved by Councillor Ernst, seconded by Councillor Carver that Municipal Council conduct Second Reading of draft version 3.1 of the Oakland Secondary Planning Strategy and Land Use By-law, as presented at the Public Hearing, and hereby adopts the documents; and further that, Council repeal the September 9, 2003 Oakland Secondary Planning Strategy and Land Use By-law, such repeal to be effective upon publication of a Public Notice advising of Council's adoption of draft version 3.1 of the Oakland Secondary Planning Strategy and Land Use By-law. Carried unanimously.

3. <u>ADJOURNMENT</u>

There being no further business at 7:30p.m., it was moved by Councillor Bell, seconded by Councillor Whynot that the meeting adjourn. Motion carried.
