5. MAYOR'S OPENING REMARKS

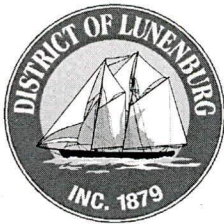
Mayor Bolivar-Getson welcomed all in attendance to the first Council meeting of the 46th term of Municipal Council.
